

2. **Admission Schedule (From Merit List):** 23 December 2024 to 30 December 2024.

3. **Admission Schedule (1st Waiting List: Candidates will be informed by the program office):**

1st Waiting List: **31 December 2024 to 06 January 2025.**

2nd Waiting List: **The list may be published depending on seat availability.**

4. **Sequence of Admission Activities:**

a. The candidates, on arrival at the MESM Program Office, must collect **Admission Form** and **Bank's Deposit Slip** for fee payment. They must bring along with them the following **Original Documents. Without original documents of all academic records, admission procedure will not be completed:**


- (i) Certificate and Transcript of SSC/O Level examination.
- (ii) Certificate and Transcript of HSC/A Level examination.
- (iii) Certificate and Transcript of Graduate Level examination.
- (iv) Nationality Certificate from UP Chairman/Ward Commissioner or National ID.
- (v) 06 (six) copies of passport size colored photograph duly attested.

b. The candidates must provide **"Medical Test Report"** that can be collected from any diagnostic center and must contain the following test results:

1. Hbs/Ag;
2. Urine R/E;
3. Blood Group;

4. The candidates declared medically fit shall have to deposit **Taka 51,500.00 (Fifty-One Thousand Five Hundred Taka Only)** to the following account:
