 - d. Equivalent Certificate for Foreign degrees holder Given by Competent Authority (e.g. Bangladesh Bar Council/ UGC/ Education Board).
 - e. Photocopy of National ID Card attested.
 - f. Five copies of passport size colored photograph duly attested²
